Cantonal Contribution for Childcare (Kantonspauschale)

- From August 2026, the Canton of Zug will introduce a cantonal contribution towards childcare costs.
- The contribution applies to childcare provided by day-care centres (Kitas) and registered childminders (Tagesfamilien).
- The contribution amounts to 33% of the average childcare rates.

Am I eligible for the Kantonspauschale?

You are eligible for the Kantonspauschale if:



- ✓ Your child resides in the Canton of Zug.
- ✓ Your child is older than 3 months.
- ✓ Your child attends a licensed day-care centre or is cared for by a registered childminder (inside or outside the Canton of Zug).
- ✓ Both parents are employed or enrolled in a state-recognised education or training programme.
- ✓ You submit a complete application.

How do I apply?

You must submit your application online through the Civo portal. You can find the link to Civo at: zg.ch/kantonspauschale.

You will need:

1. ZUGLOGIN

You can create a user account either by post or in person at a registration office. All information is available at: zuglogin.ch

2. eZug app

Download the eZug app to your smartphone (free from the App Store). Then activate the app using your ZUGLOGIN number and password.

Which documents do I need for the application?

You will need:

- ✓ Current proof of childcare in a day-care centre or with a childminder
- ✓ Current proof of employment or education/training for both parents
 - Employment confirmation OR, for self-employed persons, confirmation issued by the compensation office (Ausgleichskasse)
 - or
 - Confirmation of education or training OR proof of studies



As a rule, documents are considered current if they are not older than 6 months. The templates on the website zg.ch/kantonspauschale show which information is required.

Please note: The Kantonspauschale is granted at the earliest the month after a complete application is submitted.

What must I do if something changes?



- You must report important changes within 1 week.
- Via the Civo online portal (button “Mutation erstellen” – create change request), report for example:
 - Change in the scope of childcare
 - Change or end of childcare arrangements
 - Change or end of employment or education/training
- Report to the canton by telephone or email:
 - If the child moves away from the Canton of Zug

Childcare vouchers from your municipality

- In addition to the Kantonspauschale, you can also apply for childcare vouchers from your municipality.
- Eligibility for this support depends mainly on your income and assets.

If you live in Zug, Cham or Risch

- In Civo you can apply for the following at the same time:
 - the Kantonspauschale and
 - childcare vouchers from your municipality.
- Both parents need a ZUGLOGIN account and the eZug app if they live in the same household.
- First find out from your municipality whether you are entitled to childcare vouchers and which documents you need:

- The canton and the municipality will review applications. The respective decision will be sent to you.
